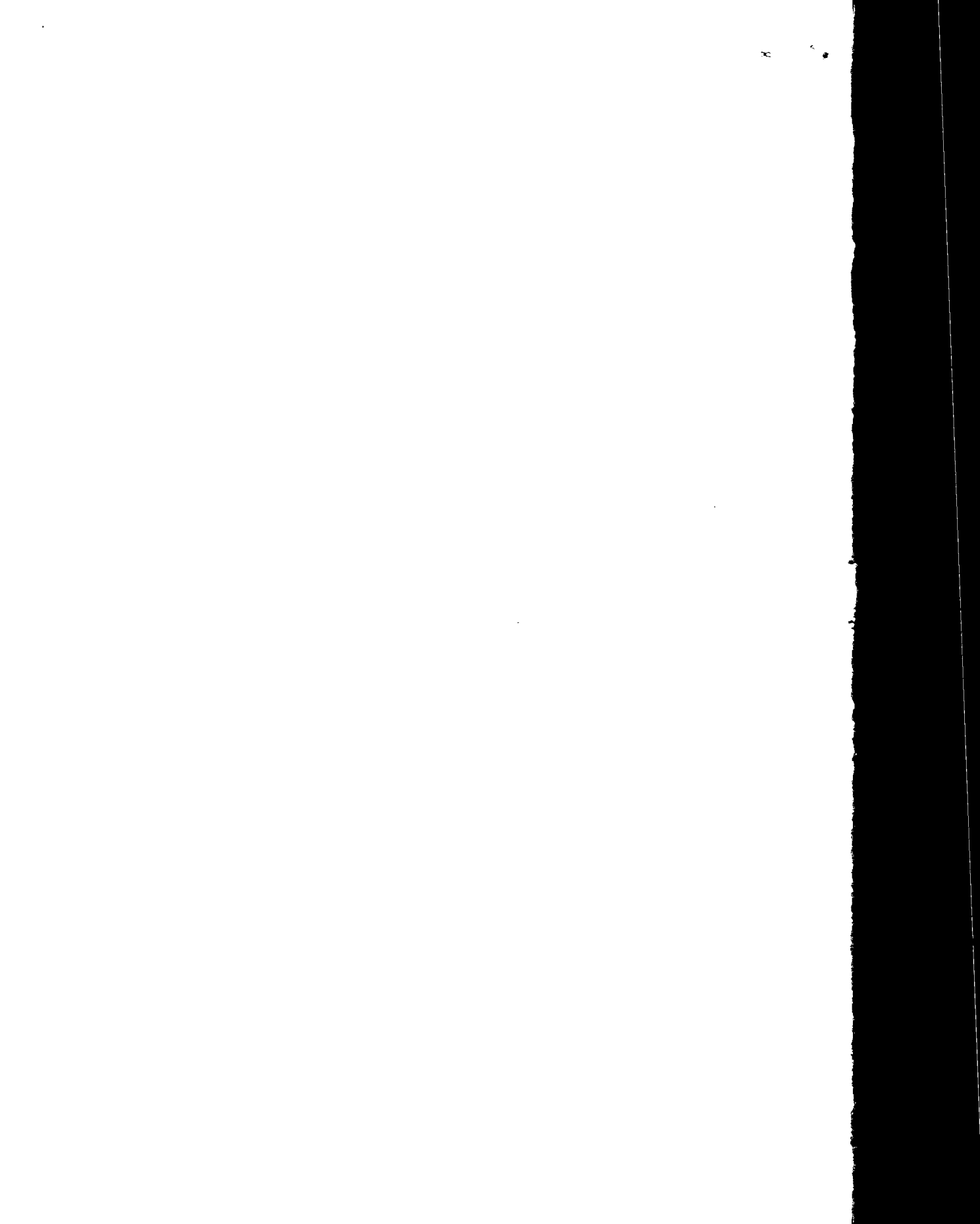

**THE SIAYA COUNTY SUPPLEMENTARY APPROPRIATION
ACT, 2017**

No. 3 of 2017

Date of Assent: 8th January, 2018

Date of Commencement: 8th January, 2018

AN ACT of the Assembly of County Government of Siaya to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2018 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Siaya, as follows—

1. This Act may be cited as the Siaya County Supplementary Appropriation Act, 2017.

Issue of KSh. 6,845,341,860 out of the County Revenue Fund for services of the year ending on the 30th June 2018 and the appropriation of the money granted

2. The Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2018, the sum of Kenya Shillings **Six Billion, Eight Hundred and Fourty Five Million, Three Hundred and Fourty One Thousand, Eight Hundred and Sixty** and that sum shall be deemed to have been appropriated as from the **1st July, 2017**, for the services and purposes specified in the Schedule.

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under section 13(2A) of the Government Financial Management Act, 2004.
