AN ACT of the County Assembly of Tharaka Nithi to authorise the issue of sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2018 and to appropriate the sum and the sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Tharaka Nithi as follows—

Short title

1. This Act may be cited as the Tharaka Nithi County Supplementary Appropriation (No.2) Act 2017.

Issue of KSh. 4,506,140,000 out of the County Revenue Fund for the service of the year ending 30th June, 2018.

2. The County Treasury may issue out the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June 2018, the sum of Kenya Shillings Four Billion, Five Hundred and Six Million, One Hundred and Forty Thousands and that sum shall be deemed to have been appropriated as from 1st July 2017.

Appropriation of the Money granted

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of those Schedules.
