

LEGAL NOTICE NO. 108

## THE BETTING, LOTTERIES AND GAMING ACT

(Cap. 131)

IN EXERCISE of the powers conferred by section 70 of the Betting, Lotteries and Gaming Act, the Vice-President and Minister for Home Affairs hereby makes the following Regulations:—

## THE BETTING, LOTTERIES AND GAMING

## (AMENDMENT) REGULATIONS 1968

1. These Regulations may be cited as the Betting, Lotteries and Gaming (Amendment) Regulations 1968, and shall be deemed to have come into operation on the 1st January 1967.

2. The Second Schedule of the Betting, Lotteries and Gaming Regulations (hereinafter referred to as the principal Regulations) is amended—

Cap. 131  
(Sub. Leg.).

- (a) in item 2 thereof (relating to totalizator licences), by replacing the figures "50", "50" and "100", which appear in the fourth column thereof, with the figures "100", "100" and "200" respectively;
- (b) in item 3 thereof (relating to pool betting scheme licences), by replacing the figures "1000" and "500", which appear in the second and third columns in relation to the sub-item "Agent's Licence", with the figures "200" and "100" respectively;
- (c) in item 7 thereof (relating to permits authorizing promotions of on-the-course lottery relating to racing), by replacing the words "For each lottery" with the words "For each race day".

3. The Third Schedule of the principal Regulations is amended by replacing form A therein with a new form as follows—

18. Has any payment for expenses or prizes been made out of moneys of the Society other than proceeds of this lottery?
19. Date of the draw.
20. Was any other lottery conducted for the Society at the same time? If so give details.
21. Has any ticket been sold to a person under the age of 16 years?

13. Has any ticket been issued otherwise than on receipt of the full purchase price?

15. Has any ticket been sent through the post?
16. Has any ticket been sold to a person under the age of 16 years?

5. There shall be inserted in the principal Regulations, immediately after regulation 13 thereof, a new regulation as follows—

13A (1) Where a lottery is promoted and conducted in the circumstances described in section 40 (1) of the Act, or a private lottery within the meaning of section 42 of the Act is promoted and conducted, the person who promotes it shall, within thirty days after the draw, make to the Board an accurate return of the lottery in the appropriate form in the Third Schedule of these Regulations.

(2) Any person who contravenes subsection (1) of this section shall be guilty of an offence.
