## THE CUSTOMS AND EXCISE ACT, 1978

(No. 10 of 1978)

IN EXERCISE of the powers conferred by section 138 (1) of the Customs and Excise Act, 1978, the Vice-President and Minister for Finance makes the following Order:—

THE CUSTOMS AND EXCISE (REMISSION) (No. 21)  
ORDER, 1980

1. This Order may be cited as the Customs and Excise (Remission) (No. 21) Order, 1980, and shall be deemed to have come into operation on the 1st January, 1979, and, unless earlier revoked, shall expire on the 28th February, 1981.

2. The whole of the import duty, suspended duty and dumping duty payable on the machinery and equipment imported by M/S Madhupaper International Limited for installation at their factory is remitted.

## THE STAMP DUTY ACT

(Cap. 480)

## EXEMPTION

IN EXERCISE of the powers conferred by section 106 of the Stamp Duty Act, the Vice-President and Minister for Finance directs that the Conveyance in respect of Land Reference Numbers 214/20/1/1 and 214/20/2 respectively situated in the City of Nairobi in the Nairobi Area shall be exempted from the provisions of the Act.

## LEGAL NOTICE No. 150

## THE LAW SOCIETY OF KENYA ACT

(Cap. 18)

IN EXERCISE of the powers conferred by section 27 of the Law Society of Kenya Act, the Council, with the approval of the Society by a special resolution, makes the following Regulations:—

THE LAW SOCIETY OF KENYA (GENERAL) (AMENDMENT)  
REGULATIONS, 1980

1. These Regulations may be cited as the Law Society of Kenya (General) (Amendment) Regulations, 1980, and shall be deemed to have come into operation on the 1st January, 1980.

2. The Law Society of Kenya (General) Regulations are amended by deleting regulation 3 and substituting the following— Sub. Leg.

3. (1) The annual subscription for membership of the Society shall be—

(a) the sum of five hundred shillings in respect of advocates whose names have been on the Roll of Advocates for five years or more;

(b) the sum of two hundred and fifty shillings in respect of non-practising advocates and practising advocates whose names have not been on the Roll of Advocates for five years; and

(c) the sum of eighty shillings in respect of non-advocates, which subscriptions shall become due and payable on the 1st January in every year.

(2) The annual subscription shall be paid—

(a) to the Registrar of the High Court in accordance with the provisions of section 27 of the Advocates Act in case of practising advocates; and Cap. 16.

(b) to the Society in case of other members.
