### THE KENYA ORDER IN COUNCIL 1963

(L.N. 245 of 1963)

IN EXERCISE of the powers conferred by section 11 of the Kenya Order in Council 1963, the Governor hereby makes the following Regulations:—

### THE KENYA (AMENDMENT OF LAWS) (MISCELLANEOUS AMENDMENTS) (No. 2) REGULATIONS, 1963

1. These Regulations may be cited as the Kenya (Amendment of Laws) (Miscellaneous Amendments) (No. 2) Regulations, 1963, and shall be deemed to have come into operation on the 1st June 1963.

2. The laws specified in the first column of the Schedule to these Regulations are amended, in relation to the provisions respectively specified in the second column of the said Schedule in the manner specified in relation thereto in the third column of the said Schedule.
