LEGAL NOTICE No. 72

THE EAST AFRICAN INCOME TAX (MANAGEMENT)  
ACT, 1958  
(No. 10 of 1958)

IN EXERCISE of the powers conferred by subsection (2) of section 12 of the East African Income Tax (Management) Act, 1958, I, Jomo Kenyatta, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya, with the approval of the National Assembly, hereby make the following Order:—

THE EAST AFRICAN INCOME TAX (MANAGEMENT)  
(EXEMPTION) ORDER, 1971

1. This Order may be cited as the East African Income Tax (Management) (Exemption) Order, 1971, and shall be deemed to have come into operation on the 1st day of January, 1971.
2. The income accruing or which accrued to the Tana River Development Company shall be exempt from tax.

LEGAL NOTICE No. 73

THE BETTING, LOTTERIES AND GAMING ACT  
(Cap. 131)

IN EXERCISE of the powers conferred by section 70 of the Betting, Lotteries and Gaming Act, the Vice-President and Minister for Home Affairs hereby makes the following Regulations:—

THE BETTING, LOTTERIES AND GAMING  
(AMENDMENT) REGULATIONS, 1971

1. These Regulations may be cited as the Betting, Lotteries and Gaming (Amendment) Regulations, 1971.
2. The Betting, Lotteries and Gaming Regulations (hereinafter referred to as the principal Regulations) are amended—
  - (a) by inserting, immediately after regulation 3 thereof, a proviso as follows—

Cap. 131  
(Sub. Leg.).

Provided that—

- (i) for every licence and permit issued in respect of any authorized race meeting which is promoted in any part of Kenya outside the boundaries of the City of Nairobi the fee shall be one-fourth of that specified in the Second Schedule to these Regulations;
  - (ii) for any lottery promoted or conducted for the purpose of raising funds exclusively for a charitable purpose the fee shall be Forty Shillings.
- (b) by deleting paragraphs (6) and (7) of regulation 5 thereof;
- (c) by inserting immediately after regulation 5 thereof a new regulation as follows—

Entry permits. 5A. (1) The Board shall cause books of entry permits in the appropriate form in the Schedule of these Regulations and numbered serially, to be printed for sale to bookmakers at a cost equal to the cost of production plus the amount of fee for each entry permit payable under these Regulations.

(2) Every permit issued by a bookmaker under this regulation shall be prepared in triplicate, and the bookmaker shall submit the duplicate copy to the Board with the fortnightly return to be rendered under regulation 6 of these Regulations, and shall retain the triplicate copy.

(3) Whenever a bookmaker admits any person into an off-the-course betting premises licensed under section 16 of the Act he shall issue to such person an entry permit under this regulation, and such a person shall not transfer such a permit to any other person.

(4) Every person issued with an entry permit under this regulation shall submit his permit for cancellation on entering a betting premises, and such cancellation shall be effected by stamping the permit with an inked rubber stamp marked with the words "CANCELLED".

(5) Any person who enters and remains within a betting premises without an entry permit issued under this regulation and any licensed bookmaker who permits any person to enter his betting premises without such an entry permit shall be guilty of an offence.

(6) Any bookmaker who permits any person to remain within his betting premises without being in possession of an entry permit which has been duly cancelled as required under paragraph (4) of this regulation or who assists any person to wrongfully acquire a duly cancelled entry permit shall be guilty of an offence.

3. The First Schedule to the principal Regulations is amended by inserting immediately after Form 16 thereof a new form as follows—
