

LEGAL NOTICE NO. 53

THE REGULATION OF WAGES AND CONDITIONS OF
EMPLOYMENT ACT

(Cap. 229)

IN EXERCISE of the powers conferred by section 11 (3) of the Regulation of Wages and Conditions of Employment Act, the Minister for Labour and Human Resource Development, having received regulation proposals, makes the following Order:—

THE REGULATION OF WAGES (PROTECTIVE SECURITY
SERVICES) (AMENDMENT) ORDER, 2003

Citation.

1. This Order may be cited as the Regulation of Wages (Protective Security Services) (Amendment) Order, 2003, and shall be deemed to have come into operation on the 1st May, 2003.

2. The Regulation of Wages (Protective Security Services) Order, 1998, in this Order referred to as "the principal Order", is amended in paragraph 5 by deleting the words "seven hundred and fifty" and substituting therefor the words "one thousand".

3. The principal Order is amended in paragraph 11 by deleting the words "forty-five days sick leave with half pay" and substituting therefor the words "fifty days sick leave with half pay".

4. The principal Order is amended by deleting paragraph 12 and substituting therefor the following new paragraph:

12. A female employee shall be entitled to two month's leave with full pay in addition to her annual leave for that year:

Provided that—

(a) childbirth shall not be deemed to be a sickness as provided for under paragraph 11 and the employer shall not be required to meet medical costs incurred in respect thereof;

(b) a female employee who takes maternity leave shall not incur any loss of privileges during that period.

5. Paragraph 15 of the principal Order is amended—

(a) in subparagraph (1) by deleting the table appearing therein and substituting therefor the following table—

(i) breakfast	95
(ii) lunch	100
(iii) dinner	120

(b) in subparagraph (2) by deleting the table appearing therein and substituting therefor the following table—

KSh

(i) for a night in Nairobi or Mombasa 420

(ii) for a night-stop elsewhere 320

6. The principal Order is amended in paragraph 18 by deleting the words "a reasonable transport allowance" and substituting therefor the words "a minimum public transport allowance".

7. Paragraph 20 of the principal Order is amended in subparagraph (2) by deleting the words "one hundred and thirty-five" and substituting therefor the words "one hundred and fifty".

8. The principal Order is amended in paragraph 22 by deleting the expression "five thousand" wherever it occurs and substituting therefor the expression "six thousand and five hundred".

9. The principal Order is amended in paragraph 27 by deleting the expression "eighteen per cent" and substituting therefor the expression "ten per cent".

10. The principal Order is amended by deleting the First Schedule and substituting therefor the following new Schedule.
