1. Citation

These Rules may be cited as the College of Arms Rules.

2. Mode of application

(1) An application for a grant of arms under section 4(1) of the Act shall be in duplicate in form CA1 in the Schedule to these Rules, and shall be made to the registrar.

(2) An application for the registration of a grant of arms under section 6(2) of the Act shall be in form CA2 in the Schedule to these Rules, and shall be made to the registrar, and shall be accompanied by the original grant, or a copy of the grant certified by or on behalf of the authority which granted the arms to be a true copy of the grant.

3. Fees

(1) The fee which a person applying for a grant of arms shall pay (in addition to the further sum which the College of Arms stipulates on account of expenses it may incur in connection with the application without prejudice to section 5(2) of the Act) shall be KSh. 10,000.

(2) A person applying for the registration of a grant of arms shall pay a fee of KSh. 5,000.

(3) Fees and further sums payable on account of expenses of the College of Arms shall be paid to the registrar.

(4) Where a grant of arms has been made and registered, the registrar shall refund to the applicant the unspent balance of the sum paid by him on account of expenses of the College of Arms.

4. Inspection of register

The register of arms may be inspected at the office of the registrar between the hours of 9. a.m. and 12.30 p.m., and between 2.15 p.m. and 3.30 p.m., on payment of a fee of Sh. 5.
