THE PUBLIC ORDER (BANNING OF POLITICAL UNIFORMS) ORDER

- 1. This Order may be cited as the Public Order (Banning of Political Uniforms) Order.
- **2.** (1) The wearing in public places or at public meetings of uniform or any distinctive dress which signifies association with any political organisation or with the promotion of any political object is hereby prohibited.
 - (2) Any person who contravenes the provisions of subparagraph (1) of this paragraph shall be guilty of an offence and liable to a fine not exceeding one thousand shillings or to imprisonment for a term not exceeding two months, or to both such fine and such imprisonment.

Section 11 of the Act is applied throughout Kenya during all hours of the day and night.

THE PUBLIC ORDER (CURFEW) (TANA RIVER, TANA NORTH AND TANA DELTA DISTRICTS) ORDER, 2012

1. This Order may be cited as the Public Order (Curfew) (Tana River, Tana North and Tana Delta Districts) Order, 2012, and shall be deemed to have come into operation on the 11th September, 2012.

 - the person has written permission from the District Commissioner, the District Officer or the officer commanding the Police unit in the respective area;
- (c) no person shall, without lawful excuse, possess or carry any offensive weapon.

THE PUBLIC ORDER (CURFEW) (MANDERA, WAJIR, GARISSA AND TANA RIVER COUNTIES) ORDER, 2015

 - (iii) the person is on transit and is on temporary accommodation in a duly licensed hospitality facility as a guest and such person has duly registered in the facility as such guest with full and proper identification recorded in the specified register for the registration of guests.
- (d) no person shall, without lawful excuse, possess or carry in public any offensive weapon.
