THE PUBLIC FEES ACT

(Cap. 424)

IN EXERCISE of the powers conferred by section 2 of the Public Fees Act, the Minister of State for Immigration and Registration of Persons makes the following Regulations:—

THE PUBLIC FEES (AMENDMENT) REGULATIONS, 2010

- 1. These Regulations may be cited as the Public Fees (Amendment) Regulations, 2010.
- 2. The Public Fees Regulations, in these Regulations referred to ass the "principal Regulations", are amended by deleting regulation 8 and substituting therefor the following new regulation—

L.N. 74/1999.

- 8 (1) The fee for the issue of a replacement of a lost passport shall be ten thousand shillings.
- (2) Subject to paragraph (1), an additional fee of five thousand shillings shall be levied for specialized expedited service, except where specifically exempted by the Minister.
- (3) For the purposes of these Regulations, "specialized expedited service" means a service offered at the request of an

applicant where a passport is issued within twenty-four hours of application.

- 3. The principal Regulations are amended by deleting regulation 9 and substituting therefor the following new regulation—
 - 9 (1) The fee for the issue of a replacement of a mutilated passport shall be eight thousand shillings.
 - (2) Subject to paragraph (1), an additional fee of five thousand shillings shall be levied for a specialized expedited service, except where specifically exempted by the Minister.

LEGAL NOTICE NO. 123

THE BILLS OF EXCHANGE ACT

(Cap. 27)

IN EXERCISE of the powers conferred by section 74C of the Bills of Exchange Act, the Central Bank of Kenya makes the following Regulations:—

THE BILLS OF EXCHANGE (CHEQUE TRUNCATION) REGULATIONS, 2010

- 1. These Regulations may be cited as the Bills of Exchange (Cheque Truncation) Regulations, 2010.
 - 2. In these Regulations, unless the context otherwise requires—

"check digit" means an automated error detection in a cheque code line;

"cheque code line" means numbers and symbols printed at the bottom of a cheque;

"document reference number" means a unique identification number assigned to a cheque for the purpose of presentment by electronic means; and

"magnetic ink character recognition" means a process used to create machine readable information on a cheque code line.

- 3. The purpose of these Regulations is to prescribe the particulars of electronic payment information and the particulars of image return documents.
- 4. The electronic payment information of a cheque shall comprise—
 - (a) the document reference number;
 - (b) the magnetic ink character recognition cheque code line, which shall contain the —
