LEGAL NOTICE NO. 272

THE CONSTITUTION OF KENYA (AMENDMENT) ACT, 1965

(No. 14 of 1965)

IN EXERCISE of the powers conferred by section 6 of the Constitution of Kenya (Amendment) Act, 1965, the President hereby makes the following Order:—

THE CONSTITUTION (AMENDMENT OF LAWS)
(PROMISSORY OATHS) ORDER, 1965

1. This Order may be cited as the Constitution (Amendment of Laws) (Promissory Oaths) Order, 1965.

2. There shall be substituted for the First and Second Schedules to the Promissory Oaths Act two new Schedules as follows:—

Kiapo cha Makamu wa Rais/Waziri

(2) *Oath of the Attorney-General*

So help me God.
