IN EXERCISE of the powers conferred by section 19 of the Local Authority Services Charge Act the Minister for Local Authorities makes the following Regulations:-

THE LOCAL AUTHORITY SERVICES CHARGE (AMENDMENT) REGULATIONS, 1999

1. These Regulations may be cited as the Local Authority Services Charge (Amendment) Regulations, 1999.

Sub-Leg. 2. The Local Authority Services Charge Regulations are amended by -

- (a) deleting the First Schedule thereto with effect from 1st January, 2001; and
- (b) deleting the Second Schedule thereto with effect from 1st January, 2000.

LEGAL NOTICE NO. 74

THE PUBLIC FEES ACT (Cap. 424)

IN EXERCISE of the powers conferred by section 2 of the Public Fees Act, the Minister for Finance makes the following Regulations:-

THE PUBLIC FEES REGULATIONS, 1999

1. These Regulations may be cited as the Public Fees Regulations, 1999.

2.(i) The fees for the issue of a new passport shall be -

(a) two thousand shillings for a thirtytwo page passport;

(b) three thousand shillings for a fortyeight page passport;

(c) four thousand shillings for a diplomatic passport;

(d) two thousand shillings for a service passport;

(e) six hundred shillings for the East African Passport.

(ii) The fee for the renewal of a passport shall be -

(a) one thousand shillings for a thirtytwo page passport;

(b) one thousand five hundred shillings for a forty-eight page passport;

(c) two thousand shillings for a diplomatic passport;

(d) one thousand shillings for a service passport;

(e) three hundred shillings for the East African Passport.

3.(a) The fee for the issue of a new certificate of identity (CIN) shall be two thousand shillings;

(b) The fee for renewal of a certificate of identity (CIN) shall be one thousand shillings.

4. The fee for the issue of a temporary permit shall be eight hundred shillings.

5. The fee for the endorsement of an existing valid passport with an amendment affecting the holder's name or profession, or height or special peculiarities, shall be five hundred shillings.

6. The fee for the endorsement of an existing valid passport with the holder's child shall be one thousand shillings per child;

7. The fee for the issue of a joint passport shall be
(a) two thousand shillings for a thirty-two page passport;

(b) three thousand shillings for forty-eight page passport.

8. The fee for the issue of a replacement of a lost passport shall be ten thousand shillings.

9. The fee for the issue of a replacement of a mutilated passport shall be eight thousand shillings.

10. The fee for a collective certificate of identity shall be two thousand shillings and one thousand shillings per person included.

11. The fee for the issue of Kenya visas shall be -

(a) fifty United States of America dollars for an ordinary or entry visa;

(b) twenty United States of America dollars for a transit visa;

(c) one hundred United States of America dollars for a multiple journey visa;

(d) ten United States of America dollars for a reference fee;

(e) gratis for diplomatic, official, service and courtesy visas.

LEGAL NOTICE NO. 75

THE INSURANCE ACT (Cap. 487)

IN EXERCISE of the powers conferred by section 180 of the Insurance Act, the Minister for Finance makes the following Regulations:-

THE INSURANCE (AMENDMENT) REGULATIONS, 1999.

1. These Regulations may be cited as the Insurance (Amendment) Regulations, 1999 and shall come into operation on the 10th June, 1999.

2. The Insurance Regulations, are amended by repealing Regulation 39 and replacing it with the following new Regulation -

39(1). For the purpose of section 153(1) of the Act, the form of guarantee which may be required of a broker by the Commissioner shall be in the form of a bank guarantee as set out in Form 153-1 in the Nineteenth Schedule or in the form of a two-year Government bond held by the Commissioner, and the minimum amount of the guarantee shall be, at the time of first registration of the broker and at the time of subsequent renewals, five hundred thousand shillings.

(2) At renewal of registration, the broker shall submit, where applicable, an additional bank guarantee or Government bond calculated at twenty-five percentum of the amount of outstanding premium in excess of the period permitted under section 156(2) of the Act, due from the broker to all insurance companies in Kenya as at 30th June previous to the date of application for renewal, less existing minimum bank guarantee.
