An Act of Parliament to amend the Constitutional Offices (Remuneration) Act

ENACTED by the Parliament of Kenya as follows:—

1. This Act may be cited as the Constitutional Offices Short title. (Remuneration) (Amendment) Act. 1985.

2. The Constitutional Offices (Remuneration) Act, in this Act referred to as the principal Act, is amended by repealing section 2 thereof and inserting the following—

Replacement of section 2 of Cap. 423.

Salaries and allowances for certain offices under the Constitution.

2. (1) The salaries to be paid to the holders of the offices specified in the first column of the Schedule to this Act, being the offices mentioned in section 104 of the Constitution, shall, with effect from the 1st July, 1985, be at the annual salary scales or rates specified in relation to those offices in the second column of that Schedule:

Provided that where a salary scale is specified the holder of the office shall be paid such salary within that scale as the President may determine.

- (2) The holders of the offices specified in the first column of the Schedule to this Act shall be paid such allowances as may be determined from time to time by the President.
- 3. The principal Act is amended by inserting immediately after section 3 the following new section—

Insertion of new section 4 in Cap. 423.

Other vilowances.

4. Nothing contained in this Act shall preclude the payment to the holder of the office specified in the first column of the Schedule any allowance not mentioned or determined in accordance with the provisions of this Act which he is eligible to receive other than by virtue of this Act.

In this Schedule-

"Job Group Q" means a salary scale commencing at £5,730 per annum increasing by annual increments of £216 to £6,594 per annum thereafter increasing by annual increments of £252 to £6,946 per annum;

"Job Group R" means a salary scale commencing at £6,594 per annum increasing by annual increments of £252 to £7,854 per annum;

"Job Group S" means a salary scale commencing at £7,350 per annum increasing by annual increments of £252 to 7,854 per annum, thereafter increasing by annual increments of £288 to £8,718 per annum;

"Job Group T" means a salary scale commencing at £9,330 per annum increasing by annual increments of £324 to £10,626 per annum, thereafter increasing by annual increments of £360 to £10,986 per annum.
