An Act of Parliament to make minor amendments to the statute law

ENACTED by the Parliament of Kenya as follows:--

1. This Act may be cited as the Statute Law (Miscellaneous Amendments) Act, 1982.

2. The several written laws specified in the first column Amendment of written of the Schedule are amended, in relation to the provisions thereof specified in the second column, in the manner specified in the third column.
