THE NATIONAL ASSEMBLY REMUNERATION (AMENDMENT) ACT, 1992

Date of Assent: 16th April, 1992

Date of Commencement: 1st July, 1991

An Act of Parliament to increase the salaries and allowances paid under the National Assembly Remuneration Act

ENACTED by the Parliament of Kenya as follows:-

1. This Act may be cited as the National Assembly Remuneration (Amendment) Act, 1992 and shall be deemed to have come into operation on the 1st July, 1991.

Short title and commencement.

2. Section 7 of the National Assembly Remuneration Act, in this Act called the principal Act, is amended—

Amendment of section 7 of Cap. 5.

- (a) in the definition of "accommodation allowance" by deleting "£1,800" and inserting "£3,780";
- (b) in the definition of "constituency allowance" by deteting "£2,200" and inserting "£2,664";
- (c) by deleting the definition of "house allowance" and inserting the following new definition—

"house allowance" means an allowance, payable when no housing accommodation is provided by the Government for the person concerned—

- (a) at the rate of £6,000 a year in respect of the Speaker, the Vice-President, other Ministers, Assistant Ministers, the Deputy Speaker and the Chief Whip; and
- (b) at the rate of £4,500 a year in respect of the Deputy Chief Whip and Members of the Chairmen's Panel.

Replacement of First Schedule to

3. The First Schedule to the principal Act is repealed and replaced by the following new Schedule-

- 4. The Second Schedule to the principal Act is amended—
- Amendment of Second Schedule to Cap. 5.
- (a) in item 1, by deleting the full stop at the end of proviso (ii) and inserting the following—
 - (iii) a member of the National Assembly representing a constituency within the Nairobi Area or an area outside Nairobi within a radius of one hundred kilometres shall be paid a commuted mileage allowance of £1,350; and such a member shall not be entitled to be paid transport allowance.
- (b) in item 2, under the column headed "Nature of Allowance" by deleting paragraph (b) and inserting the following new paragraph—
 - (b) a commuted mileage allowance for travel in and about Nairobi, where an official car is not provided, of £1,350.
