

**THE CONSTITUTIONAL OFFICES
(REMUNERATION) (AMENDMENT)
ACT, 1981**

**An Act of Parliament to amend the Constitutional Offices
(Remuneration) Act**

ENACTED by the Parliament of Kenya as follows:—

1. This Act may be cited as the Constitutional Offices (Remuneration) (Amendment) Act, 1981.

Short title.

2. The Constitutional Offices (Remuneration) Act, hereinafter called the principal Act, is amended by repealing section 2 thereof and substituting the following—

Repeal and replacement of s. 2 of Cap. 423.

2. The salaries and allowances to be paid to the holders of the offices specified in the first column of the Schedule to this Act, being the offices mentioned in section 104 of the Constitution, shall, with effect from 1st October, 1980, be at the annual salary scales or rates specified in relation to those offices in the second column of that Schedule:

Provided that where a salary scale is specified the holder of the office concerned shall be paid such salary within that scale as the President may determine.

3. The principal Act is amended by deleting the Schedule thereto and substituting the following—

Replacement of Schedule to Cap. 423.

In this Schedule—

“Job Group P” means a salary scale commencing at £4,584 per annum increasing by annual increments of £186 to £5,514 per annum;

“Job Group Q” means a salary scale commencing at £5,328 per annum increasing by one annual increment of £186 to £5,514 per annum, thereafter increasing by annual increments of £216 to £6,378 per annum;

“Job Group R” means a salary scale commencing at £6,162 per annum increasing by annual increments of £216 to £6,594 per annum, thereafter increasing by annual increments of £252 to £7,350 per annum;

“Job Group S” means a salary scale commencing at £6,846 per annum increasing by annual increments of £252 to £7,854 per annum, thereafter increasing by one annual increment of £288 to £8,142 per annum.
