#### THE NATIONAL ASSEMBLY REMUNERATION (AMENDMENT) ACT, 1986

Date of Assent: 24th July, 1986

Date of Commencement: 1st January, 1986

#### An Act of Parliament to amend the National Assembly Remuneration Act

ENACTED by the Parliament of Kenya, as follows:—

Short title and commencement. 1. This Act may be cited as the National Assembly Remuneration (Amendment) Act, 1986 and shall be deemed to have come into operation on the 1st January, 1986.

Amendment of section 7 of Cap. 5.

- 2. Section 7 of the National Assembly Remuneration Act (in this Act called the principal Act) is amended—
  - (a) by inserting the following new definition immediately before the definition of "attendance allowance"—

"accommodation allowance" means an allowance payable to the person concerned at the rate of £1,800 a year;

- (b) by deleting the definition of "attendance allowance" and inserting—
  - "attendance allowance" means an allowance payable to the person concerned for the attendance of Committee meetings of the National Assembly whenever the National Assembly is not sitting."
- (c) in the definition of "constituency allowance", by deleting "£1,500" and substituting "£2,200";
- (d) by deleting the definition of "house allowance" and inserting the following new definition—

"house allowance" means an allowance, payable when no housing accommodation is provided by the Government for the person concerned—

- (i) at the rate of £3,600 a year in respect of the Speaker, the Vice-President, other Ministers, Assistant Ministers, the Deputy Speaker, Secretary to the KANU Parliamentary Group and the Chief Whip; and
- (ii) at the rate of £2,400 a year in respect of the Deputy Chief Whip and the Members of the Chairmen's Panel.

# 3. The First Schedule to the principal Act is repealed and replaced by the following—
