## An Act of Parliament to amend the Constitutional Offices (Remuneration) Act, 1968

ENACTED by the Parliament of Kenya, as follows: --

1. This Act may be cited as the Constitutional Offices (Remuneration) (Amendment) Act, 1972.

Short title.

2. Section 2 of the Constitutional Offices (Remuneration) Act, 1968 (hereinafter referred to as the principal Act), is hereby amended by the renumbering of the existing section as subsection (1) and the addition of the following—

Amendment of section 2 of No. 64 of 1968.

- (2) A salary which is expressed in the Schedule to this Act to be payable with effect from 1st July, 1971, shall only be payable where the holder of the office concerned has opted in writing to accept the whole of any revised terms and conditions of service of which such salary forms part.
- (3) Any personal allowance, which was being paid on 30th June, 1971, to an officer mentioned in the Schedule to this Act, shall be deemed always to have been lawfully paid and shall form part of the salary of that officer from that date unless he opts under subsection (2) of this section to accept revised terms and conditions of service.
- 3. The principal Act is hereby amended by the deletion of the Schedule thereto and the substitution therefor of the following—

### In this Schedule-

"Scale M" means a salary commencing at £2,334 and increasing by annual increments of £90 to £2,604, thereafter increasing by annual increments of £108 to £2,820;

"Scale N" means a salary commencing at £2,712 and increasing by annual increments of £108 to £3,144, thereafter increasing by annual increments of £132 to £3,276.

"Scale P" means a salary commencing at £3,276 and increasing by annual increments of £132 to £3,804, thereafter increasing by annual increments of £156 to £3,960;

"Scale Q" means a salary commencing at £3,960 and increasing by annual increments of £156 to £4,584.
