THE NATIONAL ASSEMBLY REMUNERATION (AMENDMENT) ACT, 1981

Date of Assent: 14th October, 1981

Date of Commencement: 1st July, 1981

An Act of Parliament to increase salaries and allowances paid under the National Assembly Remuneration Act

ENACTED by the Parliament of Kenya as follows:—

1. This Act may be cited as the National Assembly Remuneration (Amendment) Act, 1981, and shall be deemed to have come into force on the 1st July, 1981.

Short title and commencement.

2. Section 7 of the National Assembly Remuneration Act (in this Act called the principal Act) is amended—

Amendments to s. 7 of Cap. 5.

- (a) in the definition of "constituency allowance", by deleting "£540" and substituting "£1,500";
- (b) in the definition of "house allowance", by deleting "£1,800" and substituting "£3,000";
- (c) in the definition of "sitting allowance", by deleting "£1,800" and substituting "£1,200".
- 3. The First Schedule to the principal Act is deleted and replaced by the following—
