**AN ACT TO ALLOW AND CONFIRM CERTAIN  
EXPENDITURE IN RESPECT OF THE ASSEMBLY  
AND OF THE SERVICES OF THE ORGANIZATION  
OTHER THAN SELF-CONTAINED SERVICES FOR  
THE FINANCIAL YEAR ENDING 30TH JUNE 1964**

*Date of Commencement: 31st December 1963*

ENACTED by the President of Tanganyika, the President of Uganda and the Governor of Kenya on behalf of the East African Common Services Organization with the advice and consent of the East African Central Legislative Assembly.

- Short title.           **1.** This Act may be cited as the Supplementary Appropriation (1963/1964) (General Fund Services) Act, 1963.
- Interpretation.       **2.** In this Act—  
                           “the Finance Committee” means the Committee described in paragraph (b) of Article 8 of the Constitution;  
                           “the General Fund” means the fund established under the provisions of paragraph 2 of Article 34 of the Constitution.
- Expenditure.           **3.** The expenditure out of the General Fund to the amount of twenty-four thousand, five hundred and fifty-five pounds in respect of the Services specified in the Schedule during the financial year ending on the 30th June 1964, and not provided for or not fully provided for by the Appropriation (1963/1964) (Non-Self-Contained Services) Act, 1963, is hereby allowed and confirmed.

4. The moneys granted by this Act shall be appropriated for the purposes and services specified in the Schedule.

Appropriation.

5. (1) The Accountant General of the Organization is hereby authorized, upon a warrant under the hand of the Financial Secretary, to pay out of the General Fund for the purposes and Services specified in the Schedule a sum not exceeding in the aggregate twenty-four thousand, five hundred and fifty-five pounds for the financial year ending on the 30th June 1964.

Authority to pay on warrant of Financial Secretary.

(2) Any warrant of the Financial Secretary issued under the provisions of subsection (1) of this section shall be subject to such restrictions, as to the amount of payment authorized thereby, as may be directed by the Finance Committee under the hand of the Chairman thereof.
